An Architectural Review Committee (ARC) is established in your community in order to preserve the architectural and aesthetic appearance and the natural setting and beauty of the Development, to establish and preserve a harmonious design for the development and to protect and promote the value of the property, the Lots, the Dwellings and all Improvements thereon. (FCE CC&R's Section 6.05a)

Attached is the ARC Request for Home Improvement form to be submitted prior to the commencement of any improvements, changes or additions on any part of the Property. These exterior modifications/changes could be but are not limited to the construction and installation of any dwellings, sidewalks, driveways, mailboxes, decks, patios, courtyards, swimming pools, playhouses, fences, exterior lights, painting or staining of any exterior surface, landscape lighting, landscape plantings, sheds, arbors, patio additions, fence extensions/additions or painting, etc.

The completed form and **two** (2) copies of accompanying foundation, landscaping, or landscape lighting plans, written specifications, etc. should be mailed to:

Once the Committee has made a decision, **one** (1) copy of all plans, specifications and related data submitted to the ARC shall be retained in the records of the ARC and the other copy shall be returned to the Owner submitting the same with a letter of "approved" "approved as noted" or disapproved".
